This is a Supplement to the Contract (the “Contract”) entered into by the State of Indiana, acting by and through the Indiana Department of Transportation (hereinafter referred to as “INDOT”) and the **Monroe County Community School Corporation** (hereinafter referred to as “the LPA”) dated **June 26, 2008**.

WHEREAS, INDOT and the LPA entered into a Contract required in connection with INDOT Project Number **0800012**, Project Description **develop educational materials and obtain training to conduct programs to encourage children to walk and bike to school under the Safe Routes to School (“SRTS”) program (INDOT Des. No. 0800012)**. In consideration of the mutual undertakings and covenants hereinafter set forth, the parties agree as follows:

1. The term of the contract shall be extended from December 31, 2009, to **June 30, 2010**.
2. Exhibit A shall be revised to add the following bulleted item:
 - Submit quarterly reports with updates for the project to the district LPA Programs Coordinator, beginning from January 2009.
3. All matters previously agreed to and set forth in the original Contract and not affected by this Supplement shall remain in full force and effect.

Non-Collusion

The undersigned attests, subject to the penalties for perjury, that he/she is the LPA, or that he/she is the properly authorized representative, agent, member or officer of the LPA, that he/she has not, nor has any other member, employee, representative, agent or officer of the LPA, directly or indirectly, to the best of his/her knowledge, entered into or offered to enter into any combination, collusion or agreement to receive or pay, and that he/she has not received or paid, any sum of money or other consideration for the execution of this Contract other than that which appears upon the face of this Contract.

In Witness Whereof, LPA and the State of Indiana have, through duly authorized representatives, entered into this Contract. The parties having read and understand the forgoing terms of this Contract do by their respective signatures dated below hereby agree to the terms thereof.
