Special Session, June 2, 2010 MINUTES

The Board of School Trustees of the Monroe County Community School Corporation met in special session, for which proper notice had been given, at 11:00 a.m. on Wednesday, June 2, 2010, Administration Center which is located at 315 E. North Drive, Bloomington, Indiana.

In addition to the above, 4 citizens signed the visitor list (which is included as a part of the official record of this meeting); two representatives of Bloomington Community Access TV and three representatives of WTIU were present.

Call to Order by Dr. Butler at 11:00 am

Dr. Butler explained that the only item on the agenda for this special meeting was to take action on the MCEA Bargaining Agreement.

Mr. Rubright presented the MCEA Bargaining Agreement changes as follows:

- 1) Media Specialists who were employed for the 2009-10 school year shall be assigned to their respective media centers for the 2010-11 school year
- 2) The MCEA President will be provided a full-time release during the school day to conduct Association and Corporation business for the 2010-11 school year
- 3) Board policies 3130, 3432 and 3220 will not be altered unilaterally during the term of the collective bargaining agreement ratified by the Board of School Trustees at its regular meeting on Monday, August 12, 1985.
- 4) The policies 3130, 9130, 3432 and 3220 may be altered through the discussion process upon agreement.
- 5) Special Area Teacher Assignments of elementary music, art and physical education will be assigned in accordance with the 50 unit scale.
- 6) The building principal shall consult with the school psychologist prior to assigning space within the building for testing and consultation of students.
- 7) The agreement shall remain in force from August 15, 2009, through August 14, 2011.

She called for a motion on approval of the MCEA Bargaining Agreement for August 15, 2009 through August 14, 2011 as proposed (a copy of the proposed changes is attached to and made a part of the minutes of this meeting). Ms. Wanzer so moved. Ms. Merriam seconded the motion.
