**2. Superintendent Employment Consideration**

Mr. Muehling noted that the purpose of this meeting was to consider the employment of a candidate for the position of Superintendent. Mr. Muehling reviewed the sixteen week process which began with opportunities for community input at three coffees, work sessions, executive sessions with the community panel for the superintendent search and meetings with leaders of the Community Leadership for Education. A total of 33 names were submitted for consideration, seven candidates were contacted for interviews and two finalists were chosen to meet with the following groups: building principals, Superintendent's cabinet and the public. Following those meeting, the candidates each met with the Board twice.

Following additional comments from Ms. Wanzer, Dr. Butler and Dr. Sabo-Skelton, Ms. Wanzer moved to appoint Dr. Judith DeMuth as Superintendent for the MCCSC and to offer Dr. DeMuth the standard three-year superintendent contract. Dr. Butler seconded the motion.

Mr. Muehling called for the vote on the motion to appoint Dr. Judith DeMuth as Superintendent for the MCCSC and to offer her the standard three-year superintendent contract. Aye: Butler, Klein, Muehling, Sabo-Skelton, Smith, Street and Wanzer Motion carried
